DATA PROTECTION

The Board of Management of Dunshaughlin CNS is a committee of LMETB, Abbey Road, Navan, Co. Meath which is a data controller under the General Data Protection Regulations and the Data Protection Acts 1988 - 2018. all of which are tasks carried out pursuant to various statutory duties to which LMETB is subject. The requirement to provide a birth certificate is in accordance with the Department of Education and Skills' Primary Circular 24/02, which require all primary schools to obtain and keep a copy of a student's birth certificate.
